- 1. Meeting called to order at 7:01 pm by Kevin Rogers
- 2. Reading of the Agenda
 - No additions to the agenda requested. Chair, Kevin Rogers, declares agenda as read and circulated.
- 3. Reading & Adoption of 2022 Meeting mins
 - Mark Brown motions to adopt the May 12th, 2022 Annual General Meeting minutes as presented. Rae Walker seconds. Motion carried. Minutes adopted as presented.
- 4. Chair/Trustee Report distributed (attached)
- 5. Auditor's Report/Financial Statements presented
 - Mark Brown worked as a Chartered Professional Accountant. He recommends
 that the GID investigate investment options, perhaps in the form of GIC's, for the
 purpose of long-term interest gains. Mark also recommends GID research future
 replacement costs & gain a better understanding of the financial position needed
 to provide these replacements.

6. Appointment of Auditor – 2023

 Mark Brown motions to appoint Childs Chanton Chartered Professional Accountants as GID's 2023 Auditor. Jackie Smith seconds. Motion carried. Childs Chanton Accounting firm appointed to perform GID's 2023 financial audit.

7. 2023 Budget Presented

• Ian Ball motions to adopt the 2023 budget as presented. Mark Brown seconds. Motion carried. 2023 Budget adopted as presented.

8. Election of Trustees

- Voting occurred at the GID Office polling station today, Mon. May 8th, 2023, from the hours of 9:30am-7:30pm.
- Three trustee candidates were declared for two 3-year Trustee terms (2023-2026): Jackie Smith, Ian Ball & Diana Scroggins.
- Amy Lockhart was appointed by the trustees to act as Returning Officer, who is
 responsible for the conduct of the election. The Returning Officer counted the
 ballots from the ballot box, under the observation of Wendy Settle.
- 2023 Election Results are:
 - i. Ian Ball 31 votes
 - ii. Jackie Smith 23 votes
 - iii. Diana Scroggins 22 votes

Therefore, Ian Ball was re-elected for a 3-year term (2023-2026) and Jackie Smith was re-elected for a 3-year term (2023-2026).
