TAXES AND TOLLS:

Taxes and Tolls are due and payable on or before March 31, 2015. An addition of 10% will be added to all taxes and tolls remaining unpaid after March 31, 2015. If balance is not paid 30 days after the due date, the water will be shut off. \$90.00 turn off and on fee will be charged to the property owner. The water will remain off until all fees are paid in full.

Notice: System flushing of water lines and fire hydrants will be taking place on Wednesday April 15 and Thursday April 16, 2015. This is required so that we can continue to maintain the supply of safe high quality water. There should be no interruption of water supply. During a period of several days, there may be a taste and smell of chlorine in the water. The treated water will disinfect your water lines.

Sprinkling Regulations –throughout the year.

- ◆ Odd house numbers are permitted to sprinkle on odd numbered calendar days.
- ◆ Even house numbers are permitted to sprinkle on even numbered calendar days.
- ◆ The 31st day of the month will be an off day for everyone and no watering will be permitted.
- ◆ Underground /automatic systems –12:00 midnight to 6:00 a.m.
- ◆ All manual systems - 6:00 a.m. to 10:00 a.m. and 6:00 p.m. to 10:00 p.m.
- ◆ No open hoses at any time. All hoses in use must have a nozzle or sprinkler attached to the outlet end.
- ◆ Only one sprinkler per household on manually controlled systems.
- ◆ Automatic systems are not to be used in conjunction with manually controlled systems unless approved by Board.
- ◆ Hand watering with a watering can is permitted at any time. No other hand watering is to be done outside sprinkling hours.
- ◆ A soaker hose is considered the same as an above ground sprinkler.
- ◆ All underground systems must have a backflow preventer and a rain sensor.
